## 4. FIRST AID MEASURES

## 6. ACCIDENTAL RELEASE MEASURES

<b>EMERGENCY PROCEDURES:</b>	Spillages are slippery. Ensure adequate ventilation. Keep spectators away – rope off the area. Avoid accidents, clean up immediately. Wear protective equipment to prevent skin and eye contamination.
<b>METHODS AND MATERIALS FOR CONTAINMENT AND CLEAN UP:</b>	Contain the spill and prevent run off into drains and waterways. Large spills: absorb with dry earth, sand or other similar material. Collect and seal in properly labelled drums for disposal in an area approved by local authority by-laws. Wash area down with excess water to remove residual material. Small spills: may be safely mopped up and area washed with excess water. Incineration of disposed material is not recommended, as it is unlikely to adequately burn.

## 7. HANDLING AND STORAGE

<b>PRECAUTIONS FOR SAFE HANDLING:</b>	Keep containers closed at all times - check regularly for leaks or spills. Transport and store upright. Avoid eye contact and repeated or prolonged skin contact. Do not eat, drink or smoke in contaminated areas. Always remove contaminated clothing and wash hands before eating, drinking, smoking or using the toilet. Wash contaminated clothing and other protective equipment before storage or re-use.
<b>CONDITIONS FOR SAFE STORAGE:</b>	Store in the original container, in a cool dry well-ventilated area out of sunlight and away from other chemicals and foodstuffs. Keep containers closed when not in use to ensure contamination does not occur. Do not combine part drums of the same product, as this may be a source of contamination. Do not mix with other chemicals.
